GLEN DALE CITY COUNCIL MINUTES April 12, 2021

Glen Dale City Council met in regular session on Monday, April 12, 2021, at 7:30 pm. in the Glen Dale Fireman's Hall. Those in attendance were Mayor Blazer, Recorder Trembush, Council Members: Cunningham, English, Anderson, Richmond and Zinn. Also present were Chief of Police Vogler, Street Commissioner Byers and City Clerk Criswell. Water Superintendent Orlofske and Attorney Barney were absent.

The minutes of the previous meeting were approved on a motion by Zinn and a second by English. Vote: Unanimous

Mayor Blazer recognized Brian Emery who was present to question the train traffic at odd hours during the middle of the night at Warren Distribution. He stated that they make a lot of noise and are waking his children. Councilman English was also aware of the situation and read part of City Ordinance #743.03 that states there is to be no change outs between the hours of 10:00pm and 6:00am. Mayor Blazer instructed Warren Distribution and CSX Railroad be reminded of the City Ordinance and that a copy be sent to them.

Chief Vogler introduced Cody Church to Council who was just hired as a new police officer for the City.

Zinn made a motion, second by Anderson, to accept the financial report as presented by City Clerk Criswell with no bills to be paid. Vote: Unanimous

Cunningham made a motion, second by English, to donate \$100.00 to the Knights of Columbus to help sponsor their Irish Road Bowling event. Vote: 4-0-1 (Richmond abstaining)

Zinn made a motion, second by Cunningham to table any action to Amend Ordinance 709.34 concerning Misc. Licenses to include Food Truck Vendors due to the absence of Attorney Barney. Vote: Unanimous

Cunningham made a motion to accept all standing committee reports and Richmond seconded. Vote: Unanimous

After a discussion on the removal of the dumpsters, of which there were no strong negative concerns by residents, Zinn made a motion to leave them "AS IS" and English seconded. (NO DUMPING) Vote: Unanimous

City Clerk Criswell read an Arbor Day Resolution sent on behalf of the Arbor Day Foundation recognizing the City of Glen Dale as a Tree City USA Community and for the City to participate once again. Zinn made a motion, second by English, for the Mayor to sign the

resolution to participate. Vote: Unanimous

Mayor Blazer informed Council that there are two trees in the City Park that need to be removed. He received a bid from Acorn Tree Co. to cut the trees down at a cost pf \$1,600.00. The City is take care of removal once the trees are dropped. Zinn made a motion, second by Anderson, to hire Acorn Tree Co. to do the job. Vote: Unanimous

Anderson made a motion, second by Cunningham, to adjourn at 8:550pm. Vote: Unanimous
