

GLEN DALE CITY COUNCIL MINUTES
July 27, 2020

Glen Dale City Council met in regular session on Monday, July 27, 2020, at 7:30 pm. in the Glen Dale Fireman's Hall. Those in attendance were Mayor Blazer, Recorder Trembush, Council Members: Cunningham, English, Anderson, and Zinn. Also present were Street Commissioner Byers, Attorney Barney and City Clerk Rickman. Councilman Richmond, Chief of Police Vogler and Water Superintendent Orlofske were absent.

Mayor Blazer recognized Nila Chaddock who gave an update on the Cockayne Farmstead. She also asked permission for a sign to be placed on the front of the property which would allow for upcoming events. Mayor Blazer told her to fill out a permit and Zoning Officer Grisell would need to review it.

The minutes of the previous meeting were approved on a motion by Zinn and a second by English. Vote: Unanimous

Frank Borsuk was informed by Attorney Barney that the alley in question at the last meeting was abandoned by Council in 1976 and that he (Barney) will research at the Courthouse for further information needed.

Mayor Blazer also recognized Jonathan Clarke who was summoned to give an update on his property that is identified as a "Nuisance Property". Cunningham made a motion, second by English, that noticeable work needed to be started and completed by the end of August on this property. Vote: Unanimous

Jamie Whipkey was also summoned to be present concerning his property which is also identified as a "Nuisance Property" but he did not show. Mayor Blazer requested that Chief Vogler follow up with a visit to him.

Zinn made a motion, second by Anderson, to accept the financial report as presented by City Clerk Rickman with bills in the amount of \$2,241.38 to be paid. Vote: Unanimous

Cunningham made a motion, second by Anderson, to pass on second and final reading an Ordinance of the City of Glen Dale where as Community Service Work May Be Substituted in Lieu of a Fine in Municipal Court as presented by Attorney Barney. Roll Call Vote: Cunningham-YES; English-YES; Anderson-YES and Zinn-YES. Vote: Unanimous (4-0)

English made a motion to accept all standing committee reports and Cunningham seconded. Vote: Unanimous


Zinn made a motion, second by English, to accept the bid from Country Roads Leasing,LLC to finance the purchase of a new 2020 Chevy Tahoe for the police department. Vote: Unanimous

Cunningham moved and English seconded a request to go into executive session at 8:19pm for both legal and personnel reasons. Cunningham moved and Zinn seconded the request to return to regular session at 9:03pm. Both Votes: Unanimous

Zinn made a motion, second by English, to close the Glen Dale Municipal Pool because of extenuating circumstances resulting in a lack of sufficient staffing. Vote: Unanimous

Attorney Barney swore in the newly elected Council as required.

Anderson made a motion, second by Cunningham, to adjourn at 9:07 pm. Vote: Unanimous
