

GLEN DALE CITY COUNCIL MINUTES
September 13, 2021

Glen Dale City Council met in regular session on Monday, September 13, 2021, at 7:30 pm. in the Glen Dale Fireman's Hall. Those in attendance were Mayor Blazer, Recorder Trembush, Council Members: Cunningham, English, Anderson, Richmond and Zinn. Also present were Chief of Police Vogler, Street Commissioner Byers, Attorney Barney and City Clerk Criswell. Water Superintendent Orlofske was absent.

The minutes of the previous meeting were approved on a motion by Zinn and a second by English. Vote: Unanimous

Mayor Blazer recognized the following people in the audience who were present to express their concerns as follows:

Greg Gellner asked for an update on Grandview Terrace Road and should it be referred to the Planning Commission. Richmond explained to him that Council would be "out of order" to vote on this before the Planning Commission was given the opportunity to review the situation and give a recommendation to Council. Attorney Barney later verified this process.

Franny Myers said that Jamie "Cat" Whipkey wants someone to come to his house and explain what the City wants him to do. Chief Vogler said that Mr. Whipkey has been informed of what to do and he was served with papers to appear in front of Council and he did not show and that Council's next step would be to take him to Circuit Court.

Cunningham made a motion, second by Anderson, to accept the financial report as presented by City Clerk Criswell with bills in the amount of \$9,765.92 to be paid. Vote: Unanimous

Zinn made a motion, second by Cunningham, that after proper notice Jamie Whipkey failed to appear in front of Council and therefore the situation needs to be referred to Circuit Court. Roll Call Vote: Cunningham-yes; English-yes; Anderson-yes; Richmond-yes; Zinn-yes. Motion passed 5-0

Richmond made a motion, second by Anderson, to pass on second and final reading AN ORDINANCE OF THE CITY OF GLEN DALE, WEST VIRGINIA, AMENDING ORDINANCE 1348.01. DEFINITION; CONDITIONAL USE PERMIT REQUIRED pertaining to limited video lottery establishments to coincide with W.V. State policy. ROLL CALL VOTE: Cunningham-yes; English-yes; Anderson-yes; Richmond-yes; Zinn-NO. Motion passed 4-1

Cunningham made a motion, second by English, to have a pest control company come to the Whipkey property to exterminate pest that have been reported and witnessed by the GDPD and such action recommended by Tom Cook of the Marshall County Health Department. Vote: Unanimous

English made a motion to accept all standing committee reports and Zinn seconded.
Vote: Unanimous

Council was presented with a letter from the Village of Beech Bottom asking for support with their application concerning the naming of the bridge currently under construction in southern Brooke County to be "PURPLE HEART MEMORIAL BRIDGE" honoring the military personnel that have been injured in the line of duty. Zinn made a motion, second by Anderson, to support the efforts of Beech Bottom. Vote Unanimous

Zinn made a motion, second by Cunningham, to support the Knights of Columbus "Road Bowling " fund raiser in the amount of \$100.00. Vote: 4-0-1 with Richmond abstaining.

Anderson made a motion, second by Cunningham, to adjourn at 8:00pm. Vote:
Unanimous
